# AOPA's "Pilot Passport Shares" Contest Official Rules

## WHO MAY ENTER:

Open to all individuals who legally reside in the 50 United States, the U.S. Virgin Islands and the District of Columbia 18 years of age or older who are the holders of a current FAA-issued student, sport, recreational, private, commercial, or ATP airman certificate. Employees of AOPA, its subsidiaries and affiliated companies, and the trustees, officers, directors, interns, advertising or promotion agencies of each, are not eligible to win. Any person in the immediate family of an employee (including the spouse, children, parents, brothers and sisters of any employee) living in the same household of any such employee is not eligible to win.

## **HOW TO ENTER:**

To enter, fly to an airport, utilize the "Pilot Passport" feature within the AOPA app to check in and then share your check in via any social media channel available on Pilot Passport (currently Facebook, Twitter, and the AOPA Hangar) during the Entry Period. You will receive one entry for each share of your check in on a social media channel. For clarification, a share of one check in on Facebook, Twitter, and the AOPA Hangar will count as three (3) entries.

#### ENTRY DEADLINE:

The contest begins at 12:00 AM on May 1, 2019 and ends at 11:59 PM on May 31, 2019 (the "Entry Period"). All entries must be completed during the Entry Period.

#### JUDGING:

The three (3) individuals with the highest number of social media shares, as indicated by the Pilot Passport feature during the Entry Period will be the Grand Prize winners. Grand Prize winners will be notified via email, postal service, or phone.

#### **PRIZES:**

There will be three (3) Grand Prize winners. Each Grand Prize winner will receive a \$50 gift certificate to the AOPA Pilot Gear store. Approximate retail value ("ARV") of each Grand Prize is \$50.00. ARV of all Grand Prizes is \$150.

#### **MISCELLANEOUS:**

Each participant agrees that any and all disputes and causes of action arising out of this contest shall be resolved individually and any judicial proceeding shall take place in a federal or state court within the State of Maryland.
